How CASS, Inc. Came To Be

“In the spring of 1989 Three Barb Benson (a.k.a. Dennis Hiett) and his lovely wife Lady Benson (a.k.a. Janet Hiett), went to “End of Trail™”. Overwhelmed by the camaraderie, fun spirit and family type participation that it brought to the participants, as well as spectators, Three Barb thought that this is something that would be great back East! Well, in no time at all, they were shooting Cowboy Action™! From that first time of just a few cowpokes getting together, CASS, Inc., was born. CASS, Inc. retains the honor of being known as one of the first Cowboy Action Shooting™ clubs on the East Coast and the first to be established in West Virginia.

As defined by the folks that created this shooting sport, SASS™ (Single Action Shooting Society), Cowboy Action Shooting™ a multifaceted shooting sport in which contestants compete with firearms typical of those used in taming the Old West: single action revolvers, lever action rifles and double-barreled, side-by-side, pre 1699 pump or lever action shotguns. The shooting competition is staged in a unique, characterized “Old West” style.



CASS, Inc. hosts regularly scheduled matches every fourth Sunday in the months of March through October. All persons wishing to participate are welcome.

The only exceptions to this schedule is the CASS, Inc. “Annual” shoot named “Appalachian Showdown,” which is held the fourth weekend in September.

Appalachian Showdown is a three day event, which as of the year 2000, is known as the WV State Championship.
